5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

- A. Grand Prize (1):** The grand prize winner will receive one (1) autographed Teremana branded foosball table (the “Grand Prize”). Only one (1) Grand Prize will be awarded in this Sweepstakes. The ARV of the Grand Prize is \$1,500.
- B. First Prize(s) (2):** Each first prize winner will receive one (1) Teremana branded foosball table (the “First Prize”). No more than two (2) First Prizes will be awarded in this Sweepstakes. The ARV of each First Prize is \$1,000.

THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
